You'll pay the rental fee on top of the security deposit at time of arrival to Sandhills Service to pick up key to trailer.

- > Trailers are equipped with some dishes, pots/pans, silverware, can opener, coffee maker, toaster, microwave. Bring your own bedding, towels, paper goods, etc.
- No smoking & No Pets are allowed in any of Sandhills Service Camper rental units. You will be charged a cleaning fee of \$150 (minimum).
- > Rental units must be clean upon departure, we expect them to be returned to us as clean as they are delivered. Renter will pay a cleaning fee of \$75.00 (minimum) if unit is not acceptable.
- > Sandhills Service campers have fragile septic tank systems. Please do not flush sanitary products, greasy kitchen waste or food particles down the system. Only use white RV toilet tissue like the kind Sandhills Service has. Clogged plumbing may result in additional charges.
- > Renters are responsible for park permits including State Park entry permits on their vehicles.
- Renters are responsible for any parking/traffic violation fees.
- All the rental units are subject to sale. And will be replaced by a similar unit.
- Please note, all campers are winterized and water systems including sinks, showers, and toilets are inoperable from October 1st through early May 10th of each year. Or when the temperature drops below freezing.

Acknowledgment of Risks: I understand and acknowledge that the activities, that I and those in my party, are about to engage in bear certain known risks and unanticipated risks which could result in injury, death or damage to ourselves, our property, Sandhills Service property or to other third parties and their property.
